READ CAREFULLY BEFORE SIGNING

RANGE RULE #5. **MINORS:** Minors under the age of 18 MUST be under the direct control and immediate close supervision of a parent or accompanying adult at all times when on the premises. The Rangemaster and Trapmaster will not act as an accompanying adult. The supervising adult MUST sign the Adult with Accompanying Minor Agreement before allowing a minor on the firing line. A person under 18 MUST be under the direct control of a parent or legal guardian, or have the written permission of a parent or legal guardian and be under the direct control of and adult 21 or older to fire a pistol at the WCGC.

Additionally, "Under direct control" shall mean that while the minors are shooting and/or handling a firearm, the Supervising Adult shall not shoot and shall directly supervise the minor. The Supervising Adult must remain at the side of the minor and no more than three (3) feet from the minor while minor is shooting and/or handling a firearm in any way.

Semi-automatic rifles are to be loaded with no more than six rounds total when being fired by a minor.

The under signed person hereby agrees that the Rangemaster and the Trapmaster are not responsible for supervising or controlling the conduct of shooters or visitors on the property controlled by the Winchester Canyon Gun Club {WCGC}. The undersigned specifically agrees, to assume all risks of any injury to person or property caused by' or arising out of any conduct of any person(s) or any condition of the premises, under the control of Winchester Canyon Gun Club, whether foreseeable or not foreseeable to anyone.

The undersigned hereby agrees to indemnify, save harmless and defend the Winchester Canyon Gun Club (WCGC), its agents, employees, officers and/or directors, from each and every claim, demand and/or cause of action of any kind occasioned by and/or arising out of the conduct of the undersigned, the conduct of other persons that are accompanying the undersigned upon the property of the Winchester Canyon Gun Club; and/or from the acts or omissions of the WCGC, its agents, employees, officers, and Directors, of any kind or type whatsoever.

I agree that this release and indemnity agreement shall be binding on my heirs, successors and assignees.

(2)-the minor is accompanied by a responsible adult and-HAS PRIOR WRITTEN CONSENT OF HIS OR-HER PARENT OR LEGAL GUARDIAN and is involved in one of the activities cited above."
